

# **Professional Experience**

I was directly involved in the drafting/executing of the Air Force's five-, ten- and 20-year strategic/growth/development plans and in the acquisition of major aircraft and defence systems. During this period I was awarded the *Chief of Defence Force Commendation Medal*.

During 1981 I ventured from the SA Air Force holding the rank of *Colonel* and entered the private sector as a recognised industry leader specialising in information and communication technology (ICT) solutions, where I served on several Board of Directors, variously as MD and Board Chairman, with primary focus areas and responsibilities including strategic planning, acquisitions, negotiating and structuring of joint venture companies. A particular assignment entailed taking several South African companies into the global arena – a very challenging and rewarding task. In 2005, I was honoured to receive an International Star Award (Gold) for Quality by BID (Business Initiative Directions) in Paris, and during the same time, CEO Magazine in South Africa named me a *'Titan of Transformation'* together with other prominent people in my country.
